Transformations

Dear Children of God at ALC,

From the beginning of April through the middle of May, the road up Hyalite Canyon to the Hyalite Reservoir and surrounding area is closed to cars. This provides a phenomenal biking, walking, and running situation for recreation during the spring thaw. This spring, my schedule and the weather cooperated with me to bike up the road quite a few times!

With 1,500 feet of elevation gain, the climb up isn't at all fast which gives me time to notice and reflect on my surroundings.



Each time I pedaled up, I noticed there was less and less snow. I breathed in deeply the smell of pine trees as they thawed. And I saw birds and squirrels enjoying a reprieve from winter.

The final time I went up, I witnessed something new. When I got up there, it took me a moment to get my bearings after the 8-mile climb, but for a second, I literally couldn't believe my eyes. The ice on the reservoir was completely

gone. When I had been up there just three days before, the reservoir was almost completely covered in ice. It had transformed so fast!

At first, I was frustrated that the ice had so quickly changed into water. There are so many things in this world that need to be transformed but are so slow and resistant to that transformation. But as I thought about it more, the ice didn't really just disappear in three days. For weeks the ice has been slowly melting and thinning. It took months for the ice to form and months for it to

melt. From the surface though, it was hard to tell. Although three days ago the surface was mostly covered in ice, it was a thin ice, slowly letting go of its frozen form. And with some very warm temperatures in the previous days, it made the final shift from ice to water.

What appeared to be a fast transformation really was a slow and deliberate transformation. Regardless of the speed, the transformations happened.

As I continued to reflect on this transformation, I sat on a large boulder eating some lunch before my ride back down. The part of this story about it taking three days to go from ice to water, drew

my mind to the transformation Jesus made from death to life in three days. After three days, Jesus' closest followers witnessed this ultimate transformation. This new thing that Jesus did in rising from the dead is what makes it possible for us and all of Creation to transform.

In this Easter season, we continue to remember and celebrate that the Kingdom of God is already among us. Jesus came among us and began the



work of bringing about a new kingdom; a kingdom that is unlike the kingdoms of this world. Before Jesus ascended to be with his Father, he entrusted his followers (that includes us!) with the work of continuing to bring about this new kingdom, to continue transforming the world.

So let us trust in the slow work of transformation. It is already happening in our congregation and in our community! Let us hold on to Jesus' promises that he will continue to work through the Body of Christ (you and me and ALL followers of Jesus) to bring transformation, restoration, and newness to each of us, our congregation, our community, and all the world! Thoughts on Changes

To my Brothers and Sisters in Christ,

Now that I have had time to adjust to the fact I am interim president of the council, I wanted to take this time to connect with all of you. I want to assure you that the business of the council, council committees and the special committees that have been formed are still moving forward and working on the needs, projects and responsibilities of American Lutheran. The council as well as these committees are working diligently to accomplish the goals that have been developing in the last year. In June, you will begin to notice more work being done outside of our church building, especially in the parking lot. Other changes and updates

to the building are still in the planning stages, but soon you may see more of these needed changes taking place. We will continue to seek feedback from the congregation, and you will continue to be informed of the progress made.

There are many ways you can become involved in our community outreach, Loaves and Fishes, Meals on Wheels, Dough For Daily Bread, Treats for the Montessori Parents/Teachers, and our local Benevolence. Check out the bulletin board on the wall in the back of the sanctuary and sign up where you might be called to help.

We have a unique opportunity to reach out and help one of our neighboring congregations here in Livingston. Pastor Melissa with the help of the building usage committee has been in talks with Living Hope Church to see if American Lutheran might be a temporary home for them while they are constructing a new church building. The building usage committee has been working out the details of the proposed terms of Living Hope possibly using space at ALC. It was great to see so many of you at the information and question/answer discussion on May 11th after church. Updated information was provided in weekly messages from Pastor Melissa. On June 1st the congregation will vote as to whether or not we as a church body will enter into this agreement. I ask that all members of ALC prayerfully consider this proposal and be open to where God might be leading us.

I would like to thank the council members for so graciously stepping in to fill the gaps that I need help with or may not be comfortable in taking on without help. You have been a blessing. I assure you I will do my best to see that the needs of ALC are met and taken care of. The support that I have received has been appreciated.

I encourage all members of ALC to contact me, or any member of the council if you have concerns, questions or issues of any kind. We are here to listen and try and find solutions together with you.

Information about the Possibility of Living Hope Church Using Space at ALC

Living Hope staff and members have approached this potential usage of space at ALC with the perspective that they will be guests in the ALC church building. Their hope and goal are to be a blessing to our community of faith and to leave the ALC building better than they found it.

Considerations that would be part of an agreement if we move forward with Living Hope Church using space at ALC:

- Living Hope will pay \$2500 per month for use of space at ALC. Living Hope will pay an additional \$500 for use of sanctuary and fellowship hall for funerals. Compensation for additional uses will be discussed as need arises. Living Hope will pay a security deposit of \$2500 at the beginning of their rental agreement.
- Living Hope will take care of the cost and labor of renovating the office spaces they will be using. Living Hope will first request approval from ALC for any changes made to ALC property. The renovations will remain ALC property after Living Hope moves out.
- Living Hope will have their custodian help with additional cleaning needs and snow removal at ALC. We will work out a schedule between Living Hope's custodian and ALC's custodian and snow removal volunteers. Living Hope will continue to assume the cost for this custodial (\$945 per month).
- Living Hope will have their own internet and landline phone contract and will pay for these services.
- We will be intentional about good communication between both churches. There will be weekly meetings initially to work through potential conflicts and point people for each church who will communicate with the other church.
- There will be a 6-month term for the agreement just in case it doesn't work out for whatever reason. We can renegotiate any terms at renewal times.
- Access to parking close to the ALC building will be reserved for participants in ALC activities during agreed days/times when

ALC has activities. Living Hope and ALC will send a joint mailing to residents surrounding the church to advise them of increased vehicles parking around the church and provide a method of contact to address any parking issues.

- Living Hope will use all their own kitchen supplies and will have use of one of the refrigerators.
- Living Hope staff and participants will take care to maintain a safe environment for other organizations using space at ALC and will respect space used by other organizations (especially Elevate Montessori).
- Living Hope will leave all spaces neat and in good order. Living Hope will make sure the building is secure after all activities and lights are off, etc. They will limit the number of people who have a key or the code to the back door.
- ALC reserves the right to change the regularly assigned rooms or spaces as need arises. When either church has a special event, the other church will be flexible about space scheduling. ALC events will have priority for scheduling.
- Living Hope will hold their own insurance with ALC named as additional insured.
- The agreement between the two churches would release ALC of any liability for anything that may happen at Living Hope events. Living Hope will pay for any damage their participants cause to ALC property.

Timeframe:

- Dependent on several of factors.
- Living Hope will put their buildings on the market in late June or early July 2025.
- There is a possibility that the buyer could allow Living Hope to lease back space for some time
- The earliest Living Hope might start using space at ALC would be August or whenever their buildings are sold
- They plan to begin building their new building in the Spring of 2026 (or later if their buildings haven't sold by then)
- They estimate it will take 18-24 months to build their new church home

 They are hoping their new building will be complete by Easter of 2028

What will the building usage by Living Hope look like?

- Sunday mornings
 - Worship service in sanctuary at 10:45
 - ALC would move fellowship and adult education time down to the fellowship hall
 - Living Hope has adult Sunday School before their worship service
 - Children Sunday School for Living Hope during their worship time in 3 different classrooms
- Offices to be used by Living Hope staff
 - Three offices: small room off the choir loft, a classroom upstairs, and "piano room" on lower level of classrooms
- Storage space for Living Hope
 - Worship supply storage in about half of storage room in sanctuary by elevator
 - Kitchen storage in little closet in fellowship hall next to elevator
 - Office storage in "piano room" classroom on lower level
- Activities during the week: children/youth ministries, fellowship meetings, prayer team, grief group, bible studies, and recovery ministry
 - Fellowship Hall: 12.5 hours over 4 different days
 - Back of sanctuary: 3 hours over three days
 - Sanctuary for 2 hours over two days
 - Conference/Council room: 1 hour one evening

Please contact Pastor Melissa or one of the members of the building usage committee (Leslie, Billie, Jane, Karla) for clarification or with any concerns or questions.



June 1, after worship, we will have a congregational meeting to discuss and decide on the building usage proposal of sharing space with Living Hope. The vote will be by paper ballot.

Every Sunday, when we walk through the doors of American Lutheran Church we too are entering "God's House." American Lutheran is a building where we as a congregation have experienced some of the most emotional, significant and memorable events of our lives. We've been part of and witnessed baptisms, weddings and funerals. Our own personal histories are very much tied to what has happened over the years in this building. Lasting Effects of Covid

In recent weeks we came across an article, actually an essay in the Rural Montanan, referencing the effect of the corona virus pandemic on our nation. The article was written by a student at Corvallis High School, and the student Rosalyn Schairer, did a masterful job of showing the impacts of the pandemic especially on the youth of the world. The pandemic has altered education, social skills, mental health, population, the economy, and racial ideals. Across the board, standard deviations were lower in math and reading. This shows how online schooling was not as proficient compared to "in person" schooling. Without attending school, participating in sports or other extracurricular events, social interactions were non-existent. Masks have impacted young children's, particularly preschoolers, ability to "read" emotions and develop social skills.

Adolescents assessed after the pandemic shutdowns were reported to have more symptoms of anxiety and depression. Also an example of a lack of social skills is the reported increase in bullying. The shocking revelation that is most frightening are the examples of neuroanatomical features more typical of older people's brains. In 2020 deaths for the total U.S. population increased by 19 percent.

Families were affected by the economic changes and businesses experienced major problems in the availability of workers.

The covid pandemic was the most important event that happened during this time. It changed lives due to the effects on the public as a whole. Even our Church worship changed as a

result of covid. Thank you, Lord, for our health and for protecting us.

Pastor's Report: Elevate Montessori requested an Emergency Evacuation plan; these were prepared and given to Elevate. A gift card was purchased for John West for his work on snow removal this winter. A joint will have been held on May 6 with Hope Lutheran. Pastor attended the Chico conference in April that focused on Congregation Music. A breakfast was held for women in ministry that was part of a grant. The Hunger Team will continue fundraising this summer with Livingston's Ride coinciding with a congregation picnic on July 12. Pastor will be at a conference June 7-13.

The Dream Team will meet with HRDC.


Child Protection Policy: The committee had an initial meeting to review and make changes to a sample policy. They will be meeting again.

June benevolence will go to Livingston Food Resource Center in collaboration with Farm to School of Park County and the Livingston School District. The Summer Lunch program provides nutritious lunch to all Livingston school-age children in need. Many of the children served receive free and reduced meals during the school year but face food insufficiency during the summer when the school meals are not available. The service is provided Monday through Friday, June through August, at multiple sites throughout Livingston. The LFRC manages Sacajawea Park, and Green Acres Park, serving an average of 350 meals per week.
